

Galatians 3:10~ For all those who depend upon works of Law are under a curse, for it is written: **Cursed is every one, that does not continue in all the things written in the scroll of the Law, in order to do them.**

- 1· Everyone existing under the Law Covenant was under a curse, for the Law Covenant itself said; **Cursed is every one, that does not continue in all the things written in the scroll of the Law in order to do them.** The reality was, that no man in all of Israel's history could perform the Law Covenant perfectly. They all stumbled over the stone of stumbling, that of perfect obedience of their spirit through love of God's Holy Spirit, only Christ succeeded!

[Question] What curse was everyone existing under the Law Covenant also under?

[Question] What was the truth, throughout all of Israel's history?

[Question] What course did they all stumble over?

- 2· Cursed is the one who will not put the words of this **Law** in force by doing them. And all the people must say; Amen! (**Deuteronomy 27:26**)

[Question] What was upon anyone, not putting all the words of the Law Covenant in force?

- 3· And you must say to them; This is what Yehowah the God of Israel has said; **Cursed** is the man, that does not listen to the words of this Covenant. (**Jeremiah 11:3**)

[Question] What was the man who would not listen to the words of the Law Covenant?

- 4· Now, therefore, why are you making a test of God by imposing upon the neck of the disciples, a yoke, that neither our forefathers, nor we, were capable of bearing? (**Acts of Apostles 15:10**)

[Question] What did Paul have to say about the Law Covenant, showing that no one could live by its standards successfully?

- 5· For whoever observes all the **Law**, but makes a false step in one point, he has become an offender against them all. (**James 2:10**)

[Question] What does a man become, by breaking just one Law?

- 6· When he has made her drink the water, it must also occur that if she has defiled herself, in that she committed an act of unfaithfulness toward her husband, the water that brings a **curse** must then enter into her as something bitter, and her belly must swell, and her thigh must fall away, and the woman must become a cursing in among her people. (**Numbers 5:27**)

[Question] How was a woman's faithfulness to her husband to be tested out, in a case involving jealousy?

- 7· But this crowd, that does not know the **Law**, are accursed people. (**John 7:49**)

[Question] How did the Jewish religious leaders view the people, who did not practice all the Law?

- 8· Now we know, that all the **things** the **Law** says, it addresses to those **under** the **Law**, so that every mouth may be stopped and all the world may become liable to God for punishment. (**Romans 3:19**)

[Question] Why does the Law say, all the things that it does say, about sin?

- 9· But now we have been discharged from the **Law**, because we have died, to that, by which we were being held fast, that we might be slaves in a new sense, by the spirit, and not in the old sense, by the **written** code. (**Romans 7:6**)

[Question] Through what death, are we all now discharged from the Law Covenant?

[Question] What is the purpose of our discharge from the Law Covenant?

[Question] Are we then still slaving for the same God, and according to the same principles contained within the Law Covenant?

- 10· Who has indeed adequately qualified us to be ministers of a New Covenant, not of a **written** code, but of spirit, for the **written** code condemns to death, but the spirit makes alive. (**2 Corinthians 3:6**)

[Question] What are all anointed Christians adequately qualified for, through their anointing through the Holy Spirit?

[Question] What does the written code produce, and what does the spirit within our hearts produce?

- 11· Moreover, I bear witness again to every man getting circumcised, that he is **under** obligation to perform the whole **Law**. (**Galatians 5:3**)**

[Question] What did Paul think was necessary for any man getting circumcised to also do, be he wrongly thought that circumcision was a command of the Law Covenant?

[Question] Where did the first command to circumcise our offspring come from, and what covenant was it a part of?

- 12· And blotted out the handwritten document against us, which consisted of decrees, and which was in opposition to us, and He has taken it out of the way, by nailing it to the torture stake. (**Colossians 2:14**)**

[Question] What happened to the Law Covenant, when Christ was nailed upon the stake?
