

~IMPOSED (94)

[English, compulsory, forced, obligatory]

- Shechem asked Jacob to raise the marriage money and gift **imposed** upon him very high, and he would still pay it to obtain Dinah in marriage.
- Raise very high the marriage money and gift **imposed** upon me, and I stand willing to give according to what you may say to me, only give me the young woman as a wife. ([Genesis 34:12](#))
- When men in a struggle hurt a pregnant woman, damages were to be **imposed** upon them without fail.
- And in case men should struggle with each other and they really hurt a pregnant woman and her children do come out but no fatal accident occurs, he is to have damages **imposed** upon him without fail according to what the owner of the woman may lay upon him, and he must give it through the justices. ([Exodus 21:22](#))
- If a man **imposed** a ransom price upon a man whose bull had killed another man, then he must give it without fail.
- If a ransom should be **imposed** upon him, then he must give the redemption price for his soul according to all that may be imposed upon him. ([Exodus 21:30](#))
- Nothing was to be **imposed** as a duty upon a man just married, like military service.
- In case a man takes a new wife, he should not go out into the army, nor should anything else be **imposed** onto him. He should continue exempt at his house for one year, and he must make his wife whom he has taken rejoice. ([Deuteronomy 24:5](#))
- Pharaoh Nechoh **imposed** a fine upon Israel of a hundred silver talents and one gold talent.
- And Pharaoh Nechoh got to put him in bonds at Riblah in the land of Hamath, to keep him from reigning in Jerusalem, and then **imposed** a fine upon the land of a hundred silver talents and a

gold talent. (2 Kings 23:33)

- No tax for temple upkeep was to be **imposed** upon the men working there.
- And to you men it is being made known that, as respects any of the priests and the Levites, the musicians, the doorkeepers, the Nethinim, and the workers of this house of God, no tax, tribute or toll is allowed to be **imposed** upon them. (Ezra 7:24)
- The Israelites returning from exile **imposed** upon themselves the liability to give a third of a shekel yearly for the temple upkeep.
- Also, we **imposed** upon ourselves commandments to give, each of us, a third of a shekel yearly for the service of the house of our God. (Nehemiah 10:32)
- The Jews **imposed** upon themselves to keep the festival of Purim for two days yearly.
- The Jews **imposed** and accepted upon themselves and upon their offspring and upon all those joining themselves to them, that it should not pass away, the obligation to be regularly holding these two days according to what was written concerning them and according to their appointed time in each and every year. (Esther 9:27)
- To confirm these days of Purim at their appointed times, just as Mordecai the Jew and Esther the queen had **imposed** upon them, and just as they had imposed upon their own soul and upon their offspring, the matters of the fasts and their cry for aid. (Esther 9:31)
- There were many regulations of the Holy Place, that had to do with foods and drink, and various baptisms. Such things were legal requirements pertaining to the flesh, and God **imposed** them, until the time to set things straight.
- But have to do only with foods and drinks and various baptisms. They were legal requirements pertaining to the flesh and were **imposed** until the appointed time to set things straight. (Hebrews 9:10)
